SHORES LAKE ASSESSMENT TO INCREASE

The monthly Shores' Lake assessment will be increased from \$2.40 to \$2.85 effective April 1, 2015. The increase is due to increasing costs over the years for the maintenance of the lake in accordance with the Fourth Amendment to the Master Association CC&Rs. Master Association dues have also increased from \$65 to \$70; making the total that Shores' residents will be paying to the Master Association \$70 plus the \$2.85 assessment for a total of \$72.85. You should be receiving your new Master Association coupon book by early March.
