A fiber optics presentation done by SiFi will be scheduled for all homeowners to attend, and the association's legal counsel will be present. Date to be determined.

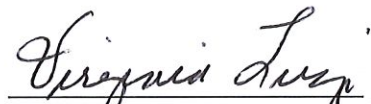

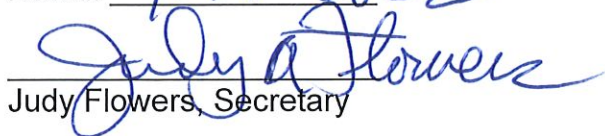
